# Drama Department

The Drama department at The King Edward VI School is seeking to appoint an outstanding and inspirational Subject Leader of Drama to lead and develop Drama across Years 9-13. This is an exciting opportunity for an ambitious practitioner to shape the direction of a thriving department, while delivering outstanding teaching across Key Stages 3, 4 and 5.

Drama holds a prominent position within the life of KEVI. It is taught weekly to all students in Year 9 and continues as a popular and successful GCSE and A Level option. Beyond the curriculum, Drama is an important extra-curricular activity. Supported by excellent facilities and a team of dedicated professionals, the department maintains an impressive programme of public performances and productions that are central to the school's cultural identity.

Although a small department, Drama at KEVI is exceptionally vibrant and plays a vital role in motivating students, building confidence and nurturing creativity. Under the leadership of the Subject Leader, the department aims to inspire students to progress to university, drama school and a wide range of creative pathways beyond school.

At examination level, the department currently follows the OCR specification for both GCSE and A Level Drama and Theatre. Student uptake at A Level continues to grow year on year, supported by strong GCSE numbers. Outcomes are consistently excellent, with A Level results achieving 100% A\* -C and GCSE results well above the national average. From 2026, we aim to offer Level 2 Performing Arts: Dance, which again will be a popular subject within the department.

At Key Stage 3, all Year 9 students follow a carefully structured programme of study exploring a broad range of dramatic styles and skills, including melodrama, pantomime and script work, laying strong foundations for further study.

The department has a long and proud history of high quality productions, ranging from large scale musicals such as Sister Act, Les Misérables, West Side Story, The

Addams Family and Annie, to studio and smaller scale performances including Teechers, The Importance of Being Earnest, dance showcases, Drama Society vignettes and a wide variety of creative projects.

The successful candidate will demonstrate a passionate commitment to inclusive, high quality Drama education and will bring the creativity, vision and leadership skills necessary to continue the department's success. They will have high expectations of both students and staff, a strong belief in the potential of every learner and the enthusiasm and drive to inspire excellence in teaching and learning across the curriculum and extra curricular provision.
