About Prudhoe Community High School

Prudhoe Community High School is a very hardworking and caring school which draws students from 100 square miles around Prudhoe.

We are a 13-19 high school with 680 students on roll including post 16 provision for 200 students. We are a small school, with an excellent reputation within the area for our excellent examination results (both Year 11 and post 16) and our pastoral care for our students. In 2016, our new school building opened. We have an environment set up to support learning for all students with new Fitness Suite, 3G pitches, Engineering, Learning Resource Centre and many more outstanding facilities across the school. In September 2023 Tyne Community Learning Trust merged with the 3 Rivers Learning Trust to become the Cheviot Learning Trust consisting of 2 high schools, 5 middle schools and 11 first schools.

One of the most exciting projects we have been working on across the MAT is the development of an 'all through' curriculum from reception through to Year 13 for each subject area. Our Subject Leaders work closely with colleagues in other schools in the Trust to ensure effective sequencing and structure of the curriculum.

We work closely with our parents/carers and directly consult via a parent/carers group which meets half

termly. There are opportunities to submit views via regular questionnaires for staff, students and parents/carers. We are part of the Cheviot Learning Trust.

Prudhoe Community High School requires a full time, Teacher of Girls' PE with the ability to teach across Key Stages 3, 4 and 5 starting in September 2026. This fixed term post will cease when the substantive postholder returns from maternity leave. This is an exciting opportunity for an ambitious and innovative teacher who wants to make a real difference to the lives of our students through their passion for teaching sport.

Early Career Teachers are welcome to apply.

The P.E. department at PCHS aims to develop positive attitudes towards physical activity so that young people become aware of the unique contribution that Physical Education makes to a full and healthy life and also to equip them with the capacity, knowledge and skills to achieve this.

The department works within the National Curriculum framework at KS3 and 4, where through a broad and balanced curriculum, students are given opportunities to plan, perform and evaluate their work. At KS4, as well as improving their performance skills, students are also given the opportunity to enhance their leadership skills and will take on the role of coach and official.

Activities taught include:

Football, rugby, basketball, gymnastics, tennis, cricket, health and fitness, volleyball, athletics, badminton, softball, trampolining, table tennis, netball, rugby, gymnastics, aerobics, health and fitness, dance and rounder

Extra-curricular activities

The P.E. department offers an extensive extra curricular programme. Clubs are run after school and are open to everyone regardless of ability. Clubs are offered in a variety of activities in order to appeal to and include as many students as possible. Inter-school fixtures are arranged in most of the above activities as well as cross-country, golf and swimming. The school also organise an outdoor and adventurous course as well as a skiing trip.

Examination P.E.

OCR GCSE P.E. has traditionally been one of the best performing subjects in the school and continues to be. Students receive 5 periods per fortnight in year 10 and 6 periods per fortnight in year 11. Generally two lessons are practical with three or four being theory lessons.

AQA A level P.E. has been a popular and successful option at key stage 5.

We also offer Cambridge Technical Diploma in Sport and Physical Activity at Level 3 and are adding the single qualification to the curriculum from September 2026. This vocational course achieves exceptional results with all students having achieved at least 'Distinction Distinction' since we started delivering this course in 2017.

Facilities

The school enjoys extensive sports facilities including a £1M Football Foundation funded floodlit 3G pitches.

Time Allocation

KS3/4 P.E. is allocated 4 periods of 60 minutes per fortnight.

GCSE PE (OCR) allocation is 5/ 6 periods per fortnight, in addition to the core P.E. allocation.

At Post - 16 students are not timetabled PE but are allowed to use the facilities when they are free.

A-level PE (AQA) receive 8/9 periods per fortnight (depending on group size)

Cambridge Technicals Level 3 Diploma in Sport and Physical Activity receive 18 periods per fortnight.

Leadership Courses

In the sixth form we have a Coaching Academy where students will complete Leadership Level 2 and 3, a Level 1 coaching badge in the sport of their choice and a first aid qualification. This group is heavily involved in the community with many students recording over 100 hours of community service during their time in the sixth form. We also run our own version of Level 1 in Sports Leadership at Key Stage 4. All these courses are well established and popular with our students.

In conclusion, we are a successful department both in terms of academic and Core PE. Our extra curricular programme is extensive, building on the Core programme, broadening the opportunities to participate both at recreational and at a competitive level. We have teams and individuals in a variety of sports that are successful locally, regionally and at national level. We have past students that are currently playing professionally in sports such as golf, athletics, cricket, football, rugby union and basketball. Participation levels are very high and students enjoy our subject. Students want to do PE and we work hard so they have the opportunities to flourish.

This is an excellent opportunity to join a dynamic and forward thinking school, with an aspiration to be one of the best schools in the North East..

Responsible to: Subject Leader for PE for the teaching role and Head of Year for any Tutor role

Job Summary:

- To contribute to the development of the department of PE including extra curricular opportunities
- To maintain an effective learning environment
- To undertake a teaching responsibility across the full age and ability range
- To be a Form Tutor, and to deliver and contribute to the development of the tutorial programme.

Duties and key result areas:

- To work in accordance with the School's Policies and the School's Improvement Plan
- To be responsible to the link member of the SLT
- To have a teaching responsibility within the PE Department
- To support the development of efficient school tracking and assessment systems.
